
1954 decision

separate-but-equal doctrine reversed

1963 Alabama Governor George Wallace vowed "segregation forever" and stood in a school house door to keep blacks from enrolling at the University of Alabama.



President Kennedy orders National Guard to remove governor and allow black students to enroll

That evening Kennedy gave a televised speech, making a plea for civil rights in America.





Landmark US Supreme Court Cases—interracial marriage--Loving v Virginia 1967





 Richard Loving "They sentenced us to one year in the state penitentiary. Then they suspended for 25 years and said that we had to leave the state."



The Pentagon Papers

1971 decision

The Washington Post and the New York Times published details of the American role in the Vietnam War.

After appeals by the government, the Supreme Court ruled that the newspapers had the right to publish the information.

(First Amendment—Freedom of the Press)



Roe v Wade 1973 decision Legalized abortion June 2022—In a 6 to 3 ruling the Supreme Court overturned Roe v. Wade, eliminating the constitutional right to abortion after almost 50 years in a decision that will transform American life, reshape the nation's politics and lead to all but total bans on the procedure in about half of the states.

The Death Penalty 1972

The Supreme Court ruled that the death penalty was "cruel and unusual punishment" (against the 8th Amendment)



The Death Penalty 1976

The Supreme Court ruled that the death penalty was not unconstitutional if it was applied fairly.

Constitutional Amendments

Some are contained in the Bill of Rights (the first 10 Amendments to the Constitution).

Some have been added by Congress over the years.



Constitutional Amendments

Nineteenth Amendment—Women's right to vote—The Anthony Amendment 1920







At her trial she said, "I shall never pay a dollar of your unjust penalty," and vowed to "educate all women to do precisely as I have done, rebel against your man-made, unjust unconstitutional forms of law, which tax, fine, imprison and hang women while denying them the right of representation in the government."

Act of Congress The Civil Rights Act of 1964

Passage of the Act **ended** the application of "Jim Crow" laws.



1971 Voting age lowered to 18
