- 12-13 aged students for grammar classes

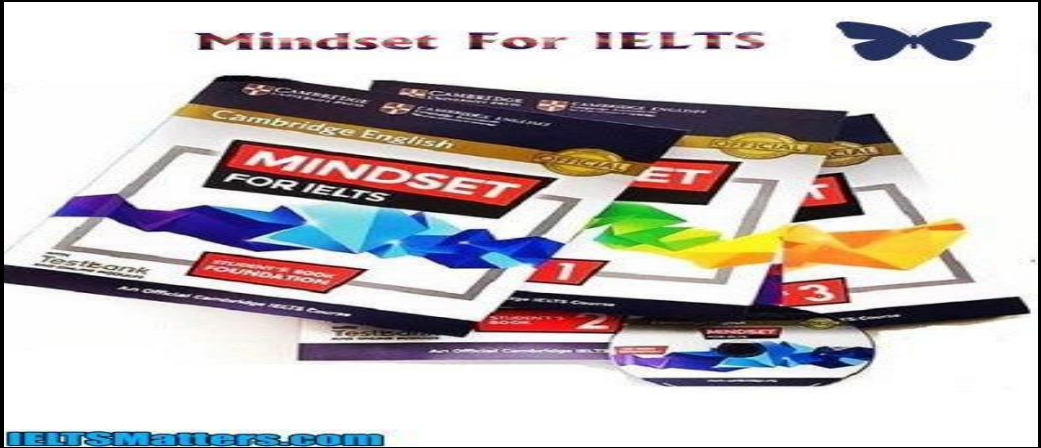
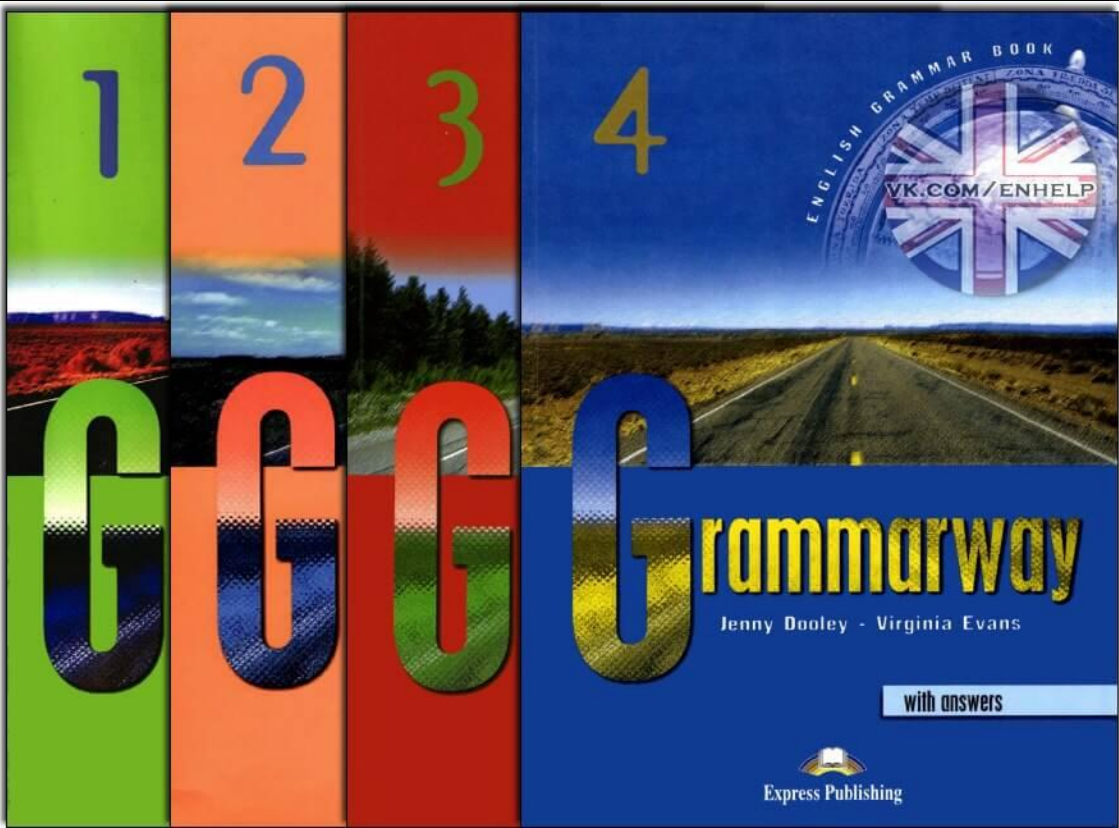

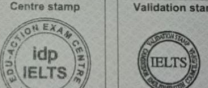
