

(Indices, 2008=100)





World trade and GDP have grown in tandem for the last ten years. Both have increased by 26 per cent since 2008.














Среднее расстояние до страны-импортера, тыс. км.













General government debt as a percentage of GDP in 2007 and 2017*









Which Countries are EU Contributors and Beneficiaries?



International Tourism Receipts in 2018 (US\$ billion)*





How to Read this Map: This map shows the biggest international tourism receipts in 2018. Each country is sized to reflect the amount of tourism receipts, countries appear bigger as their tourism receipts are higher, for example: USA. Conversely, countries with smaller tourism receipts appear smaller, for example: El Salvador
